
# PATROL AREA MAP







# **USE OF FORCE**

# 69,367 CALLS FOR 263 (0.38%) INCIDENTS HAD OFFICERS USE FORCE TO GAIN COMPLIANCE

### **USE OF FORCE DEMOGRAPHICS**

#### **ARMED SUSPECTS**

Officers responded to 40 calls where it was reported that the suspect was armed with a deadly weapon. Of those calls, 30 suspects were found to be armed.

### **PHYSICAL RESISTANCE**

There were 111 (42.2%) incidents where a suspect physically resisted an arrest and 32 (12.1%) incidents where the suspect resisted and was physically aggressive. In cases where officers used force, 54.3% of their suspects initiated physical force against the officer. There were a total of 22 assaults on officers of the Cheyenne Police Department.

### **INJURIES**

Despite **143 incidents** involving physical resistance, there were only 47 (17.8%) incidents where suspects suffered injuries as a result of police contact. There were 19 suspects who received treatment for injuries suffered prior to the officer arriving and using force. Officers reported being assaulted in 22 incidents and reported being injured in 18 of those incidents.

### SUBSTANCE ABUSE

Officers reported suspects using drugs and/or alcohol in 142 (56.8%) of the incidents where force was used. Mental illness was cited as a factor in 52 incidents with 17 of those also including drugs and/or alcohol use. There were 14 incidents where officers used force to effect a civil hold in 2020.

### **REASON FORCE WAS USED**


Officers reported that in **163 incidents**, force was necessary to affect an arrest. Officers used force 75 times in order to defend themselves or others during the course of 2020.

### **TYPES OF FORCE**

The predominate force used by officers during 2020 was Control Holds.

The types of force used by officers are as follows:

107 POINT FIREARM (40.6%)
98 TAKE DOWNS (37.2%)
54 WRAP (20.5%)
46 HANDS & FEET (17.4%)
12 TASER (4.5%)




### POLICE FORCE REVIEW BOARD

# CPD IS THE FIRST LAW ENFORCEMENT AGENCY IN WYOMING TO INCLUDE CITIZENS ON A POLICE FORCE REVIEW BOARD

In November 2020, three civilians, Stephen Latham, Mike Solis, and Melvin Turner, Jr. were chosen to serve on the Cheyenne Police Department's Police Force Review Board. The board meets monthly to review use-of-force incidents involving CPD officers. All board members have attended, and will continue to attend, force related training as a team. The Cheyenne Police Force Review Board is the first board to have citizens reviewing force used by officers in the State of Wyoming.

# **MENTAL HEALTH**

#### **CRISIS INTERVENTION TRAINING**

To best serve individuals during mental health calls for service, the Cheyenne Police Department trains its officers in crisis intervention.

The **Crisis Intervention Team (CIT)** program is a community partnership of law enforcement, mental health and addiction professionals, individuals who live with mental illness and/ or addiction disorders, their families and other advocates. It is an innovative first-responder model of police-based crisis intervention training to help persons with mental disorders and/or addictions access medical treatment rather than place them in the criminal justice system due to illness related behaviors. It also promotes officer safety and the safety of the individual in crisis.

The CIT Model reduces both stigma and the need for further involvement with the criminal justice system. CIT provides a forum for effective problem solving regarding the interaction between the criminal justice and mental health care system and **creates the context for sustainable change.** 

Research also shows that communities that prescribe to the CIT Program model, have higher success rates in resolving serious crisis situations.


The Cheyenne Police Department continues to expand it's recruiting strategy by **utilizing online job sites** to target individuals interested in a law enforcement career.



## **TRAFFIC UNIT**

The Cheyenne Police Traffic Unit encourages traffic safety through enforcement of Cheyenne's traffic ordinances. The primary goal of the unit is to modify dangerous driving behavior through **education and enforcement**, while also working to reduce traffic collisions, injuries and fatalities by addressing the factors that cause them.

The unit was short staffed in 2020, averaging 3 active officers throughout the year while normal staffing is 6 officers. COVID-19 appeared to affect traffic volume in 2020 with **fewer drivers on the road**, especially in the first 2/3 of the year. Additionally, school closures in March significantly reduced school zone and bus related violations.

# 2801 CITATIONS WERE MADE BY THE TRAFFIC UNIT, ACCOUNTING FOR 63% OF CITATIONS ISSUED BY THE DEPARTMENT.



# COMMUNITY SERVICE OFFICERS (CSO)

#### **OVERVIEW**

**Community Service Officers (CSOs)** assist police officers with community care-taking and law enforcement duties. They may be volunteers or, at the discretion of the police chief, paid employees.

CSOs are assigned either to Patrol or Municipal Security functions. **Patrol CSOs** fill a limited authority uniformed position and are responsible for handling non-emergency calls for service in support of the Police Department Patrol Division.

**Municipal Security Officers (MSOs)** fill an armed limited authority uniformed position and ensure the safety of the Cheyenne Municipal Court and court employees against unauthorized, illegal, and potentially lifethreatening activities.

# **CITIZENS ON PATROL (COPS)**

#### **COMMUNITY VOLUNTEERS**

**The Citizens on Patrol (COP)** program is comprised of community volunteers who have a desire to assist the CPD with non-emergent routine patrols and tasks that free-up police officers for more expedited police response. In 2020, **COPs contributed 3,045.2 volunteer hours** to the CPD.



# K9 UNIT

#### **OVERVIEW**

The Cheyenne Police Department **K9 Unit** is comprised of **three dual purpose** K9s and **one scent specific** K9. Dual purpose K9s are trained to find the odor of illegal drugs and are also trained to perform patrol functions.

Each K9 assists patrol and drug enforcement units in a variety of applications. K9 teams are trained in drug detection, tracking, apprehensions, building searches, area searches, patrol route searches, and use of force.

The dogs are assigned to one handler and live with the officer at home. The handler is responsible for feeding, grooming, and caring for the dog. K9's and handlers complete a rigorous **eight week training** upon their assignment. Once the teams are in service, they must **train individually each day** to maintain their skills and then train **twice monthly as a full unit.** 

The patrol vehicles assigned to handlers are specially equipped to allow a comfortable and secure area for the dog to ride on patrol. Water and climate control devices are in place to ensure the K9 is protected from the environment.

Once the K9 is taken out of active service due to age or medical problems, it is usually retained by its handler where it continues to be a member of the handler's family.



### APRIL 29, 2020


Bomb Technicians responded to a construction site where a suspicious item was found. The item was determined, by Bomb Technicians, to be an inert 60mm mortar (pictured right).

### JULY 2, 2020

Bomb Technicians responded to Torrington, Wyoming after receiving a report that the town's 4th of July fireworks show prematurity went off inside of a building. Bomb Technicians cleared the scene and removed 43 unfired commercial grade fireworks mortars from the debris. The removed mortars included 3 inch, 4 inch, and 5 inch mortars, which were transported to the City of Torrington landfill and counter-charged at the location (pictured below).

# SWAT

#### CITY OF CHEYENNE & LARAMIE COUNTY JOINT TEAM

#### **REACTIVE MISSIONS**

**7/18/2020** The SWAT Team activated and responded to a residence at the 1200 block of Taft Ave. for an armed barricaded suspect and domestic violence with a firearm. After the suspect failed to respond to multiple communication attempts by the Crisis Negotiations Unit to surrender, the SWAT Team forced entry into the residence. Moments later the suspect surrendered to members of the SWAT Team and was apprehended without incident.

8/23/2020 The SWAT Team activated and responded to a residence in the 2100 block of Cheyenne Pl. for a possible hostage situation and domestic violence with a firearm. Witnesses reported hearing multiple gun shots and then seeing an adult male yelling for help as he ran away from an adult female holding a handgun. Both subjects entered a shed on the property, and refused to communicate with responding patrol officers. SWAT Team members surrounded the property and members of the Crisis Negotiations Unit attempted to establish communication with the subjects. After a short period of time, the male subject came out of the shed and was taken to safety by members of the SWAT Team. Approximately 20 minutes later, the female suspect came out of the shed and surrendered to members of the SWAT Team. The suspect was apprehended without incident.

**8/31/2020** The SWAT Team activated and responded to a residence in the 2500 block of Windwood Dr. for an armed barricaded suspect after an aggravated domestic assault with a knife. Patrol officers responded to a female victim who was stabbed multiple times at the residence, but was able to get out with the assistance from the responding officers. Officers then entered the residence to make contact with the suspect, who swung a sharp object at patrol officers before barricading himself in a large hallway closet. The suspect refused to surrender to officers and members of the SWAT Team. SWAT Team members then introduced chemical munitions into the suspects hiding space, causing the suspect to leave the closet and surrender to the SWAT Team. The suspect was then apprehended without further incident.

#### **PLANNED OPERATIONS**

**6/5/2020** Two elements (10 Operators) of the SWAT Team activated and sent to Casper (WY) as a Quick Reaction Force (QRF)/Rescue Team in support of the Casper Police Department's Field Force Operations for a planned protest within their jurisdiction. The planned protest was peaceful and ended without incident.

**10/30/2020** The SWAT Team activated for a High-Risk Warrant Service in the 300 block of E. Prosser Rd. Detectives with the Laramie County Sheriff's Department requested assistance with a search warrant for a residence at that location, reference a prior assault with a firearm. Members of the SWAT Team executed the warrant service and was able to safely detain the occupants for questioning by LCSO detectives, and make the residence safe for a subsequent search relating to their investigation.

**11/24/2020** The SWAT Team activated for a High-Risk Warrant Service in the 1100 block of Albin Ln. Detectives with the Cheyenne Police Department's Community Action Team (CAT) and members of the DEA Task Force requested assistance with a search warrant for a residence/property at that location, reference an on-going narcotics investigation. Members of the SWAT Team executed the warrant service and was able to safely detain the main suspect of the investigation for questioning by Task Force members, and make the area safe for a subsequent search relating to their investigation.

# **DETECTIVE BUREAU**


#### **CASE ASSIGNMENTS**

Felony cases, as determined by Wyoming statute, are forwarded to the Detective Bureau for review and assignment. Cases that do not have workable leads are not assigned to a Detective, and instead go into


an inactive status pending any changes or developments. Each detective is typically working on 25-30 different cases at any given time and are masters at multi-tasking based on prioritization and current events.






### **DRUG DISTRIBUTION CASES**

# **PROPERTY & EVIDENCE**

#### PHYSICAL PROPERTY

The **Property and Evidence Section** has **51,929 pieces of physical evidence** in storage. There was an **11% decrease** in overall intake of physical property. Drug related items reduced by nearly 18%. The decrease can be attributed to the COVID-19 pandemic.

Drug paraphernalia accounted for approximately 43% of the drug related items collected by Cheyenne Police Officers. Of the remaining drug related items, marijuana and methamphetamine continued the trend of being the most common type of drugs seized at 23.7% and 18.1% respectively. There are **no significant increases or decreases** in any type of drug collected by officers in 2020 compared to previous years.

#### **DIGITAL EVIDENCE**

The CPD currently has **154,430 digital records** to include photos, video and audio files. **73,238 of those files were submitted in 2020.** This is an approximate **16% decrease** from 2019 submissions, which can be attributed to both the COVID-19 pandemic and to vastly improved disposal efforts. **1052 cases were sent** to the District Attorney's Office and the City Prosecutors office.

#### **EVIDENCE DISPOSAL**

The Administrative Disposal Procedure Memorandum between the Cheyenne Police Department, the City Attorney's Office and the District Attorney's Office was created to expedite the disposal of certain case types, freeing up much needed storage space for future evidence. This went into effect in February 2020.


The agreement had a tremendous impact on both areas of the Evidence Section and has enabled destruction of far more digital evidence in a more **timely and efficient** manner than previous years.

Additionally, the Property and Evidence Section made great strides in clearing up much needed space on the CPD's digital database.

In early September, 40,000 digital items were pending review and the number was **reduced by half** at the end of 2020.

# VICTIM ASSISTANCE

#### **SUCCESSES & HIGHLIGHTS**

The Cheyenne Police Department Victim Assistance Program (CPDVA) maintains a staff of two full-time Advocates and a Program Coordinator. Former full-time/parttime Advocate, **Brenda Johnson**, retired in March of 2020 after serving 22 years in victim advocacy.

In 2020, staff attended and completed inperson and virtual training to include The Wyoming Joint Symposium on Children and Youth Conference, the Division of Victim Services Mandatory Director Training, and Line of Duty Death (LODD) Committee meetings.

#### **KEEPING CLASSROOMS SAFE**

School Resource Officers (SROs) protect the school environment and maintain a safe atmosphere in the classroom. They assume many roles and are committed to supporting students, not only in their education, but also in other aspects shaping their lives.

SROs visit classrooms to talk about laws and ordinances, bullying, and other issues to help the students become better citizens. SROs also investigate thefts, narcotics, vandalisms and other crimes that occur within the schools.

#### **COVID-19**

During the COVID-19 shut down, all School Resource Officers (SROs) worked from home and took low priority calls for service to assist the patrol division.

This operation kept a healthy squad of officers available to fill in when regular patrol officers were out of service with COVID-19 or other illness and manpower was an issue.
